Forum on Public and Citizen Diplomacy

Outcomes Report

This report summarises the main outcomes of the Forum on Public and Citizen Diplomacy held in Canberra at the Hedley Bull Centre on 6-7 June 2011. The Forum was hosted by the Australian Institute of International Affairs in partnership with the Asia Pacific College of Diplomacy at the Australian National University and in collaboration with the Department of Foreign Affairs and Trade. The event was supported by the Department of Foreign Affairs and Trade, the Ian Potter Foundation, the National Film and Sound Archive and the Embassy of the Kingdom of the Netherlands.

The Forum, held over two days, brought together a variety of government officials, academics, professionals and other experts to discuss, debate and engage with the many contemporary issues in public diplomacy and the various citizen diplomacy resources present in Australia today. The object of the Forum was to address the role of public and citizen diplomacy in shaping Australia's image in the world.

Highlights of the Forum included:

- Participation by two international keynote guest speakers from the Netherlands and the United States
- Twenty-five speakers including diplomats, members of parliament, media representatives, non-government organisations, government officials and academics
- Coverage of a range of issues including the experience of public and citizen diplomacy in Australia and the role of the media and social media in shaping public and citizen diplomacy
- Cultural screening in conjunction with the National Film and Sound Archive
- The overall program and program organisation received a 4.6 out of a possible 5.0 rating from participants
- Expert facilitation by ABC journalist Virginia Haussegger
- Preparation of a summary of proceedings and delivery of recommendations to the Department of Foreign Affairs and Trade.

Objectives

The objective of the forum was to create an increased understanding of public and citizen diplomacy and how it aids in influencing and projecting the international image of Australia.

Public and citizen diplomacy are vital tools that can be used to augment normal diplomatic procedure. Unlike traditional diplomacy, which concentrates on government-to-government interaction, public and citizen diplomacy are the tools required to build understanding with foreign publics. Public diplomacy discussions includes a range of activities aimed at influencing the views of international publics (government to public) while citizen diplomacy focuses on citizen to citizen contact that builds cultural awareness and understanding and can improve relations between countries.

The Forum brought together leading experts from Australia and overseas and generated a vision for the future course of public and citizen diplomacy in Australia. International speakers included:

Specific objectives included:

- To bring together a select group of Australian experts to discuss public and citizen diplomacy
- To analyse Australia's current engagement in public and citizen diplomacy
- To debate, share ideas and formulate recommendations for the future direction of Australia's public and citizen diplomacy plan
- To educate the public about Australia's engagement in public and citizen diplomacy
- To establish a platform for future collaboration between the diplomatic and governmental policy makers and the institutions that participate in public and citizen diplomacy
- To produce solid policy recommendations for Australia's public and citizen diplomacy program

Following Day One, the National Film and Sound Archive organized a screening of the film "They're a Weird Mob."
