ABOUT US

The Australian Institute of International Affairs (AIIA) is an apolitical, independent membership-based organisation which promotes the objective study of International Affairs. It is apolitical and provides a forum for discussion and debate on international issues. Founded in 1925, it was established as a Federal organisation in 1933. The Institute now has its National Headquarters in Canberra. It has branches in all States and Canberra. Like its sister Institutes in New Zealand, Canada, South Africa and India, it is affiliated with the Royal Institute of International Affairs, Chatham House, London.

The AIIA provides a forum for discussion and research on subjects of topical and continuing interest through meetings, study tours, conferences and seminars addressed by distinguished specialists and public figures.

AllA Victoria is housed in Dyason House in East Melbourne, named after E.C. Dyason, a prominent past member and one of its most generous benefactors.

Membership is open to any individuals who are Australian residents, to corporate bodies, to diplomatic representatives, schools and students.

PRESIDENT'S REPORT

The year to 30 June 2020 was going along swimmingly well; until the lockdowns as a result of COVID-19 hit.

Thank you to all members who have been most supportive of the AIIA through your membership, attending events and study tours and your donations. This support of yours does much to encourage me and everyone else involved in the AIIA to improve our offerings to you.

During the first nine months of the year, we were having about one Dyason House event weekly except over the

Christmas and New Year period. The bulk of the work for these events fell mostly on Alastair and Ingrid. It was terrific seeing how easily and seamlessly Alastair and Ingrid led the AIIA in Australia into bringing to you the webinars. Post COVID-19, they have continued to have at least one event each week.

The efforts of many made the Sir Zelman Cowen Oration led by Kelly MacDonald and the International Careers Conference led by Warren Evans most successful. The Hon. Margaret Stone AO FAAL, Inspector-General of Intelligence and Security gave the most interesting of insights about her job to a very attentive audience. Professor the Hon Gareth Evans AC QC FASSA FAIIA was the keynote speaker at the International Careers Conference and drew a record crowd.

Furthermore, we receive terrific help from our Interns and Volunteers. Their contribution must not be under-rated for without them, we could not support the many activities we carry out. They are listed on page 9.



Annual Giving and Benefaction

Thank you to all for participating in Annual Giving. Your response this year was wonderful. Again, over 10% of our membership donated. This is an extraordinary healthy number and demonstrates your support for the organisation. The medium donation was \$200; with some being given jointly. Never hesitate in giving a small amount because "every mickle makes a muckle". We raised just under \$24,000 in our Annual Giving Program. When added to other Donations received during the year, the total amount given is over \$30,000; a terrific result given the state of the economy and that we are all hurting financially to some extent.

We are again most grateful to The Walter Mangold Trust Fund for its support of our Interns, particularly on Study Tours, volunteers and youth. The impact of their giving is vital in the support they give. That support was crucial in funding some to attend the AIIA National Conference in Canberra and the International Careers Conference in Melbourne.

Study Tours

After running two study tours last year we decided to have a smaller program this year. We had a terrific Study Tour of Taiwan; a most incredible country with a population the size of Australia and less than half the area of Tasmania. We were lucky enough to have Manting Chong as our intern; fluent in Mandarin.

There were thirteen delegates on the Study Tour. It was a busy tour in that we averaged more than one meeting each day. One of the highlights were visiting a fourteen-storey farm producing over two tonnes of food daily. Others were being entertained by their Ministries of Economics and Foreign Affairs. We met with the personal adviser to President Tsai and with other Think Tanks. We learned about their history and culture. Their geography is incredibly beautiful with the plains on the West, the rugged coastline on the East and the high country in the centre of the island where many of the aboriginal tribes live.

Looking back, it was not surprising that Taiwan has escaped the worst ravages of COVID-19. The TECO office in Melbourne and our representative in Taiwan both were most helpful in making the Study Tour seamless and most worthwhile.

Council Membership

The support we receive from your Council Members is of the greatest importance. Alastair and I continue to rely greatly on it. Much of the work on our programs is carried out by them.

Joan Beaumont, Jean Dunn, Benjamin Freeman, John Richardson and Kay Stevens (as Vice President) all joined the Council during the year.

Cate Pickett resigned as Vice President during the year. We thank her for her wonderful service to the AIIA over many years. John Webb, Warren Evans and Kay Stevens all resigned from the Council during the year.

Each of John Woods and Greg Wills, having given dedicated and very valuable service to the Institute over the past six years, retire from Council in accordance with clause 14.9 of the Constitution and are therefore not eligible for re-election. David Harper has also advised that he will retire as Vice-President and as a member of Council at the AGM. The Council and the Institute are deeply indebted to all of them.

We thank all our resigned and retiring Councillors for their contribution to the AIIA. During their time on Council, they contributed in so many ways to give our membership broader and more interesting topics.

Honorary Councillors

It has been invaluable having access to our Honorary Councillors from time to time to cover various matters. All have taken a keen interest in the affairs of the AlIA and made solid contributions. It is with regret that Jonathan Forster resigned as an Honorary Councillor.

Dyason House

We continued to carefully examine the future or Dyason House and our requirements. One conclusion is certain; Dyason House is not suitable for the growth and development of the Institute. It continues, through repairs and maintenance, to be a burden on our finances. Some members have resigned because of the difficulty of access. The increased attendance prior to the COVID-19 restrictions resulted in our having to impose wait-lists for some events because of the size limitations of the Sir Russel Madigan Room.

The Future

The limitations on our activities as a result of COVID-19 will not last forever. We therefore continue to plan for the future. We still hope to have the Silk Road Study Tour at some point. Dana Rice, one of the interns for the Silk Road Study Tour has already done much preparatory work in arranging meetings and the itinerary as well as organising one webinar to do with that Study Tour already.

If we are prevented from going on the Silk Road Study tour, we already have plans in place for a Study Tour to the Pacific. Ewan McDonald who is Head of the Office of the Pacific in DFAT has been most helpful in guiding us. That would mean doing the Silk Road Study tour later in 2021 or in 2022.

Our Executive

I would lastly but not least, like to thank Alastair and Ingrid for the continual smooth and seamless running of the office in support of all our activities.

This is my last report as President. Over the past six years of my Presidency, a number of significant changes have occurred in AIIA Victoria. Much of this has come about because of the terrific support and great contributions made by many Council Members and particularly Alastair Roff. I think that you will see a different sort of Council in the future with a different focus.

The stepping stones I wished to accomplish during my Presidency were to have a better organised executive, a strong and committed Council, an improved offering of Dyason House Events and Study Tours to our members, the introduction of Annual Giving and the redevelopment of Dyason House. I regret not accomplishing the last step; but it needs to be done and I leave that to the next President. It will be a fitting tribute to that person.

FINANCES

We are pleased to report that AIIA Victoria last year returned a small profit of \$10,317.

By comparison, the profit in the previous financial year was \$7,878 and despite the COVID-19 pandemic and the impact on our operating activities this is a great outcome.

All membership activities of the Institute (Memberships, Functions and Events, and Study Tours) saw strong financial performance. Our members and friends of the Institute contributed significantly to the results through their generous donations. The government support packages have also assisted in maintaining the financial performance of the Institute in the later part of the financial year. This has provided relief from the impact of revenue reduction as result of restrictions and supported our costs of remaining open.

The overall financial performance is again another positive step forward for the Institute as it has enabled us to maintain our financial position. Cash reserves have increased year on year and there is over \$200,000 in cash reserves at balance date.

The forecast for the 2021 financial year is a small profit, largely supported by the expected Government fiscal assistance. Obviously, the ongoing pandemic creates significant financial uncertainty, and the Executive and the Council members have committed to undertaking strict monitoring of the financial performance against the forecast in the coming year to ensure the Institute remains in a positive financial position.

EXECUTIVE DIRECTOR'S REPORT

I am pleased to report on a very active year across all facets of the Institute's operations. Thanks are due to members of Council for their support and involvement throughout the year, and to Ingrid Valladares our Office Coordinator for so competently helping to run the Executive Office.

Equally, we could not operate without the time and effort so generously given by our many Interns and volunteers, and more details of their contribution are given on page 9.

We again enjoyed very close cooperation from the Victoria State Office of the Department of Foreign Affairs and Trade (DFAT) and were able to host at Dyason House several visiting Ambassadors and Heads of Mission, whose insights into their respective areas of responsibility are always appreciated. Our relations with the wider Consular Corps in Melbourne are strong and expanding.

48 regular events were held this year covering a wide range of international topics, 6 more than the previous year, and over 4,000 members and guests participated. Brexit; US Foreign Policy; US-China Tensions; Health Security Policy; Australia's Future in Space Exploration; Asia after the Pandemic and many others were discussed in depth. The UK and the EU featured strongly as did India, Taiwan, the Middle East, Indonesia, and the wider Indo-Pacific. A new series of *Women in International Affairs* has been a great success and will be continued as a regular feature.

Having started 2020 with a series of successful full-house events, the Council took the decision on 16 March to suspend all in-person events until further notice. With great innovation and teamwork, we were able within two weeks to replace the speaker program with webinars, and we have endeavoured to maintain as regular and varied a program as we can in order to keep our members engaged during lockdown. One advantage of the webinars is that it enables us to reach a wider audience as well as to host experts from overseas, and it is likely that we will continue to live-stream and record events once we are able to resume public gatherings.

The <u>Walter Mangold Trust Fund</u> has again in calendar years 2019 and 2020 provided generous support to our young people. Their funding has allowed over 750 student attendances at Dyason House events free of charge and enabled us to keep student membership rates at an affordable level.

Our aim is to ensure the sustainability of the Institute post-COVID in what is an increasingly competitive environment and we are confident that we have the team to meet this challenge.

Finally, my thanks for the interest and support shown by all members and their guests at our events, and we look forward to when we can once again meet up in person.

STUDY TOURS

Taiwan November 2019

Taiwan has been a focal point of Sino-American relations in the Indo-Pacific region of the last 40 years. Our visit was prior to the presidential election in January 2020. In early November 2019, a delegation of 13 AIIA members travelled to Taiwan, the Republic of China for a two-weeklong study tour.

The delegation encompassed a wide range of professions, from medical to investing, from engineering to academia. During this two-weeklong study tour, the delegation travelled from the

north of Taiwan (Taipei) down to the south of Taiwan (Tainan)

and up to the Taroko National Park and Alishan (the Ali Mountain) for tourist attractions and other sightseeing activities.



The tour aimed to gather a full understanding of how Taiwan has transformed itself politically and economically, from a developing country with martial law to a prosperous, democratic country with its own democratically elected government.



The delegation attended various meetings with vital Taiwanese stakeholders, such as the Australian Office in Taipei, the National Taiwan Normal University, the Yes iFarm, the Taiwan Institute of Economic Research, the Ministry of Economic Affairs, the Institute of National Policy Research, the Trade investment Queensland and the Taiwan Foundation for Democracy.

On the first day, the delegation met with Mr Gary Cowan, who is the Australian Representative in Taipei. He shared in-depth

information on Taiwan's current political situation and economic development with the delegation. He also highlighted the importance of Taiwanese-Australian bilateral relationships.

The delegation also visited the Yes iFarm which has innovative solutions to modern farming practice; having developed a 14-storey farm! We visited Pastor Wong of the Tong Kwang Church. It was the first church in Asia to support the LGBTIQ movement. It played a pivotal role in the process of legalising gay marriage in Taiwan.

The Taiwan Institute of Economic Research shared many insights about the US/China trade war and how it affects Taiwan economically and politically.

The highlight of the study tour was the meetings with the minister Ms Cynthia Kiang of the Ministry of Economic Affairs and with Mr Tien, the chairman of the Institute of National Policy Research. Both these meetings were genuinely impactful. In the meeting with the National Taiwan Normal University, the Dean had expressed keen interest to establish long term relationship with Australia and with the AIIA. These meetings made us acutely aware of the fragile relationship Taiwan has with China.

On the second last day of the study tour, the delegation had met with the Taiwan Foundation for Democracy with the President Mr Bo Tedards. He shared insights on how Taiwan had successfully moved forward from martial law in 1949 through to 1987 to now a thriving democracy.

This Taiwan study tour was a massive success with AIIA Victoria building and strengthening partnership with the Taiwanese counterparts and with interns likely to come in 2020 as a result of a new working relationship between the National Taiwan Normal University and the AIIA.

15th INTERNATIONAL CAREERS CONFERENCE 2019

The 2019 International Careers Conference (ICC) was the 15th iteration of what has become one of the Institute's flagship events. It is a complex and multifaceted conference to produce, involving considerable research, marketing, communications and administration, as well as deft execution on the day. Preparations began in February, with a six-month timeline and a sizeable team contributing to the effort. Its success, as the premier, one-day conference for upcoming professionals interested in a career with an international outlook, is a tribute to the hard work of all involved.

The ICC continues to build on the experience of previous years, and the 2019 edition further refined the structure and content of the conference in response to attendee feedback and insights from the organising team, resulting in a streamlined experience that delivered informative, relevant and timely advice to a highly-engaged audience. The ICC organising committee was led by Chair Warren Evans, with support from Deputy Chair Benjamin Freeman, a team of six committed and proactive interns, and Alastair Roff and Ingrid Valladares at the Institute's office.

In 2019, the ICC adopted a similar format to that implemented in 2018. The day started with a keynote address, So You Want to be a Diplomat delivered by Prof. The Hon Gareth Evans AC QC FASSA FAIIA. Gareth Evans spoke to his lengthy and diverse career and provided the captivated audience with a range of valuable insights in both establishing a career in international affairs and being successful in it. Following the keynote address, the conference featured a series of panel discussions, covering a



broad spectrum of international careers in business, law, not-for-profits, academia, government and more. To streamline the Q&A component of the panel session, the organising committee decided to implement, for the first time, a mobile application enabling attendees to submit their questions via their phone. Other attendees could then vote for the questions they were most interested in an answer to, ensuring that the most pertinent queries were discussed.

The afternoon Career Workshops in 2018 were rebranded as Masterclasses for the 2019 ICC, more accurately reflecting their style and substance. Again, they presented Conference attendees with the opportunity to interact in small, relaxed groups with professionals in the earlier stage of their careers, to learn more about the pathway into a specific industry. The Masterclasses covered Foreign Affairs and Diplomacy; United Nations; International Law; Defence, Intelligence and Cyber; National Security; Conflict Reconstruction and Disaster Management; International NGO; Not-for-Profit Sector; Academia, Think Tanks and Research; International Business, and Victoria's International Engagement. Thanks to the extensive efforts of the team at the Institute, the interns and the volunteers, close to 250 attendees flowed seamlessly between 12 different Masterclasses running concurrently over a three-hour period.

We wish to thank the 2019 ICC sponsors: ANU College of Asia & The Pacific, and the National Security College of the ANU.

This one-day event is the product of months of planning and preparation by a dedicated team. At the Conference, it is supported by a large number of Institute volunteers, who help to deliver a carefully structured event with many moving parts. The success of the 2019 event is undoubtedly enhancing the Institute's reputation and will continue to drive greater engagement with Melbourne's young professionals.

YOUNG PROFESSIONALS

FY19/20 was a big year for the newly named AIIA Victoria Young Professionals. Following a change in identity to reflect the prevailing interests of the younger AIIAV membership, the portfolio underwent a restructure. We welcomed onto the Council Mitchell Vandewerdt-Holman who, along with the existing Council member James Carey, sought to clarify the suite of programs and events on offer for our younger members. We also want to note the invaluable contributions of Ingrid Valladares and Karla Lockett, who with Mitch and James formed the core Young Professionals working group.

This change in structure was followed by a large-scale campaign of asking younger members and non-members who attended events what they wanted to see more of and, using that information, we restructured existing programs and events. The feedback was that the 'Young Professionals Forum' was a confusing brand and that more networking events were preferable. Responding to this, the YPF brand was retired, along with its social media presence, and pulled back under the AllAV branding. During 2019, we ran events on how to network, an international careers information evening, a hypothetical event with the ANU Coral Bell School of Asia Pacific Affairs, as well as our yearly Thesis



Showcase, which allows young scholars to present their research. These were all well received and widely attended. Additionally, we ran an in-person trivia night in the centre of Melbourne, which was open to the wider community.

In 2020, we had big plans to launch an in-person monthly networking event, with a different speaker each month, held at the Kelvin Club. The appetite for such events was overwhelming, as the first of these events in March, with Richard Iron CMG OBE as the guest speaker, had well over 100 booked tickets. This event was advertised through various channels and alumni groups and promised to lead to a fantastic and profitable series. However, with COVID-19 changing the environment within which we operated our events, we had to quickly shift to an online offering.

We began this by beginning bi-weekly coffee catch-ups for younger members to discuss international affairs, current events, and their lives in lockdown. These have attracted a core group of volunteers and interns and have proven to be a really successful way to ensure that those volunteers can still feel connected to the AIIA. More broadly during lockdown, the YP has run a Hypothetical event with the US Consul-General, Michael F. Kleine, and three virtual trivia nights that have attracted a wide range of members and non-members.

In addition to these events, James launched the 'Meet The Diplomat' series. This series, which has been generously supported by DFAT Victoria State Office has to date interviewed former Ambassadors John Richardson and Colin Heseltine, and the current Australian Ambassador for Gender Equality, HE Ms Julie-Ann Guivarra. It aims to allow younger members to hear about what it is like to be a diplomat, and the types of experiences they have in their careers.

For the coming year, the new YP aims to build upon these successes and develop new funding streams for the AIIAV by providing engaging and relevant content for members and non-members. Whilst COVID-19 has forced the YP to reconsider the types of programs and events we had planned, the continual development of new events has allowed us to pivot effectively so that we can still deliver interesting content, add value to the AIIAV as a whole, and enrich the personal and professional lives of our young members.

VICTORIAN GLOBAL POLITICS ESSAY COMPETITION 2019

In 2019 AIIA Victoria and Social Education Victoria (SEV) successfully ran the third Global Politics essay competition with a number of students across Victoria lodging essays. We appointed three interns to liaise with schools: Mitchell Vandewerdt-Holman, Kate Clayton and Shanika Saputantrie, and they each did an outstanding job.

Students were asked to submit a 1,000-word essay on one of the following topics:

- Climate change moves from crisis to emergency, yet world leaders hang back from acting. Analyse.
- The involvement of the United Nations in any existing global crisis has only ever served to exacerbate the situation.
- Evaluate the effective use of power by two or more states in the pursuit of their national interests.

At the International Careers Conference in August 2019 the winners were announced, and prizes were presented by Patrick Moore. The first prize winner was Sam Warner from Mazenod College who received \$500. The second prize winner was India Rowe of Star of the Sea College, Brighton who received \$300. The equal-third prize winners were Billy Pearson of Brighton Grammar and Liam Taylor of Christian Brothers College St Kilda who each received \$100.
