Dr Bryce Wakefield Australian Institute of International Affairs

Dr Bryce Wakefield is the National Executive Director of the Australian Institute of International Affairs (AIIA) and a Visiting Fellow at the Australian National University. Previously, Bryce was the associate responsible for Northeast Asian programs at the Woodrow Wilson International Center for Scholars in Washington, DC (2008-2012), and a tenured lecturer of area studies and international relations at Leiden University in the Netherlands (2012-2018). Bryce lived in Japan from 1998 to 2004 and earned his master's degree from Osaka University's School of International Public Policy. He earned his PhD in political studies from the University of Auckland. His expertise is on International Relations and the international affairs of

Professor Geun Lee Korea Foundation



Professor Geun Lee is the President of the Korea Foundation. Prior to joining the Foundation, he was a professor of International Relations at the Graduate School and former Dean of Office of International Affairs, Seoul National University. He is also former Chair of the Global Agenda Council on the Future of Korea at World Economic Forum (Davos Forum), and currently a member of Global Future Council of World Economic Forum. Before joining the faculty of Seoul National University, he served as a professor at the Institute of Foreign Affairs and National Security (IFANS, Currently, Korean National Diplomatic Academy), Ministry of Foreign Affairs of Korea. He received his B.A. in political science from Seoul National University, and M.A. and Ph.D in political science from the University of Wisconsin at Madison, U.S.A.






Keynote Speaker: Richard Broinowski AO Former Australian Ambassador to the Republic of Korea

Richard Broinowski obtained his Bachelor of Laws degree at Adelaide University in 1961 and later

earned a Master Degree in Public Administration from the John F. Kennedy School at Harvard (1978). Richard joined the Department of External Affairs in 1963 and studied Japanese at ANU. He was posted to Tokyo as Third Secretary in 1965, then as First Secretary to Rangoon (1970-71) and Tehran (1972-73), and as Councillor and Deputy Head of Mission to Manila from 1975 to 1977. He was Executive Director of the Japan Secretariat in Canberra from 1979 to 1982. Richard was appointed as Ambassador to the Socialist Republic of Vietnam from 1983-85, and to the Republic of Korea from 1987-89. In 1994 he was appointed Ambassador to Mexico, with concurrent accreditation to the Central American Republics and Cuba. Richard retired from DFAT in 1997, and became an Adjunct Professor in Media and Communications, first at the



University of Canberra, then at Sydney University. During his time in Sydney, Mr Broinowski was the president of the AIIA NSW (2014-2017).

Miriam Carter Indo-Pacific Centre for Health Security



Miriam joined the Indo-Pacific Centre for Health Security at DFAT as Director, Strategy & Multilateral in April 2020, as the global COVID-19 pandemic really took hold. Highlights of Miri's career to date include being deployed on humanitarian response operations in Indonesia; managing health, education, youth employment and disabilities programs in Timor-Leste; promoting aid effectiveness principles as a part of a joint WHO-World Bank team based in Geneva; leading components of DFAT's Ebola Response Taskforce; and acting as Departmental Liaison Officer and Development Adviser in the office of the former Foreign Minister, the Hon Julie Bishop MP. Miri has been posted in Indonesia, Timor-Leste and

Switzerland. Prior to joining DFAT she worked for AusAID, the World Health Organization, and World Vision Australia. Miri holds a Master's degree in International Affairs from the Australian National University, and is currently completing a Masters of International Public Health through the University of New South Wales, specialising in Infectious Diseases Control.





Dr Youngmee Jee Special Representative for Health Diplomacy of the Korea Foundation



Dr. Youngmee Jee is a Special Representative for Health Diplomacy of the Korea Foundation and a member of the WHO International Health Regulation (IHR) Emergency Committee on COVID-19 Outbreak and of the WHO Scientific Advisory Group for the Blueprint on Research and Development Preparedness for Epidemics. She is currently an Advisor to the Global Center for Infectious Diseases, SNU College of Medicine and Long-Term Expert Advisor of the Korea Research Institute of Bioscience and Biotechnology. From 2014 to 2019, she served as Director-General of the Center for Infectious Disease Research of the Korea National Institute of Health (NIH), the Korea Centers for Disease Control and Prevention, and headed the KNIH as Acting Director between January and October 2019. Dr Jee received her M.D. from Seoul

National University Medical School (1986), a Diploma in Medical Microbiology (1988) and her Ph.D. in Virology from the University of London (1997).

Professor Michael Baker University of Otago



Professor Michael Baker is an epidemiologist with the University of Otago, Wellington. Baker is a member of the New Zealand Food Safety Authority's Academy and of the New Zealand Ministry of Health's Pandemic Influenza Technical Advisory Group (PITAG). Baker studied at the University of Otago, where he graduated MB ChB and earned a Diploma in Public Health, and the University of Auckland where he obtained a Diploma in Obstetrics. Prior to joining the Department of Public Health at the University of Otago, he was a medical advisor for the Minister of Health. In January 2020, Baker was asked to join the Ministry of Health's COVID-19 Technical Advisory Group.





Dr Lauren Richardson Australian National University

Lauren Richardson is a Lecturer in the Department of International Relations. Previously she taught Northeast Asian Relations at the University of Edinburgh. Her research focuses on the role of nonstate actors in shaping diplomatic interactions in Northeast Asia, particularly Japan-Korea relations. She obtained her BA and MA degrees in Asian Studies from Monash University. She then completed a Master's in Political Science at Keio University in Tokyo. Her PhD at ANU entailed one year of field work in both Japan and South Korea. She has been a visiting fellow at the Japan Institute of International Affairs and Keio University and currently a member of the Australian Committee of the Council for Security Cooperation in the Asia Pacific (AUS-CSCAP) and a Board Member of the ANU Korea Institute.



Professor Seong-ho Sheen Seoul National University

Seong-ho Sheen is Professor of International Security and East Asia, and former Dean for Office of International Affairs in Seoul National University. Prior to joining the SNU, he has taught at University of Massachusetts Boston. In addition, he advised various government organizations including ROK National Ministry of Defense, Ministry of Foreign Affairs, Ministry of Unification and Committee on Foreign Affairs and Unification, the ROK National Assembly. His area of interest includes International Security, US Foreign Policy, Northeast Asian Politics and the Korean Peninsula. Professor Sheen received his Ph.D. and M.A. from the Fletcher School of Law and Diplomacy, Tufts University and his B.A. from Seoul National University.

Alexander has published extensively on Japan-Russia relations and international relations in Northeast Asia. He holds an LLM in International Law from Tokyo University and a PhD in International Relations from the LSE.

Erin is an international relations consultant with a track record of delivering programs, policy, and research for Australian and foreign governments, universities, and not-for-profits.
